



DirectAxis Summer “Feels like...” COMPETITION RULES – October 2024

Read these competition rules carefully. These competition rules (“rules”) explain your rights and duties under this competition. If you take part in this competition or accept any prize, these rules will apply to you and you agree that the person running the competition (“the promoter/s”) can assume that you have read and agreed to be legally bound by these competition rules.

Competition Name:	DirectAxis Radio Competition
Promoter(s) Name(s):	The promoter of this competition is DirectAxis , a business unit of FirstRand Bank Limited with Reg. No. 1929/001225/06 (“DA”). In these rules we refer to the above promoter(s) as “the promoter(s)” or “DA”. We refer to participants and winners as “you”.
Entries open and close:	Competition opens the week of 04 th November 2024: 08:00 am Competition closes on the week of 13 December 2024: 08:00am Weekly Entries close at 12:00 pm The promoter(s) reserve the right to extend the competition. Notice of this will be posted in these rules.
What is the prize?	Winners will win a weekly R5000 cash prize sent electronically via EFT to a verified bank account or paid through electronic wallet/money transfer solution.
Winner/s announced on:	Winner will be announced live on-air during each week of the competition.
Eligibility: Who qualifies to take part?	This competition is open to all individuals over the age of 18 who live in the Republic of South Africa. The individuals must hold a valid South African (SA) ID or a valid SA passport.
Who cannot take part?	The following persons may not take part in this competition even if they qualify to take part. They will forfeit (give up) any prizes awarded to them: <ul style="list-style-type: none"> a) Any employee of the promoter(s). b) Any director, member, partner, agent of, or consultant of the promoter(s). c) Any other person who is directly or indirectly controls the promoter(s). d) Any supplier of goods and services in connection with this competition. e) The spouse, life partner, siblings, children, or parents of any of the persons named in a, b, c, or d, above.

How to enter?	<p>Listeners will be asked to call in, send a WhatsApp etc to talk about their “Feels Like moment.</p> <p>The competition will run over 6 weeks during November/December 2024.</p> <p>In each week, the radio announcer will ask listeners to submit their application via the website talking about their “Feels Like...” moment.</p> <p>They will then automatically be entered into the competition.</p> <p>Each radio station will select a total of 6 winners each over the competition period (04 Nov – 09 December 2024).</p>
Is there a limit on the number of times you can enter?	An individual can only enter the competition once (1) time per week per radio station, however they can only win once at each radio station for the duration of the competition.
How will winner(s) be chosen?	Stations will select one weekly winner from the pool of entries received for that week.
How will winner(s) names be announced?	<u>Please note</u> : On air during competition moment
Deadline for claiming prize(s)	30 business days for claiming prize and payment

General Rules

IMPORTANT – PRIVACY MATTERS

Participants in this competition understand and agree that for us to offer this competition, we may collect and use personal information about participants. This personal information may include your first name, last name, email address, mobile number, ID number and in certain instances your image. IMPORTANT – LIABILITY

You agree to indemnify the promoter(s) fully for any loss or damage the promoter(s) may suffer because you breached the competition rules. This means you agree to reimburse the promoter(s) for the following: any loss or damage they suffer, any expenses and costs they paid or are responsible for. Legal costs mean costs on an attorney and own client scale.

You also agree to indemnify the promoter(s) for any loss or damage you suffered because you took part in this competition or received or used any benefit or prize. - If DA is not able to get hold of you after making reasonable efforts to do so, DA can award the prize to someone else. If you don't claim your prize on time, you will lose your right to any prize.
- If you are in breach of these rules, you will be disqualified and you will lose your right to any prize(s).
- You may not sell the prize or give it to someone else. You may not swap the prize for cash or for a different prize.

- The judges' decision is final and no correspondence will be entered into. This means you cannot appeal any decision by the judges.

- DA can change the rules of the competition at any time. For convenience only, the date on which these general rules were last changed by DA are published below the heading. It is your responsibility to check the rules for any changes.

You must not copy or use another person's ideas, work or photos without their permission. By submitting anything, you warrant to DA that you are the sole creator, designer, author or owner of the work and that you have the right to use or submit the work. If we believe anything you submit or post may be plagiarism or be an infringement of another person's intellectual property rights, we may remove your submission without notice to you and you will be disqualified.
- You may not submit anything that could be offensive or may offend or harm DA or any person. Do not submit anything that contains explicit or offensive content.
- You agree that DA alone can decide if your actions are prohibited or inappropriate. DA can also decide to end your participation in the competition immediately. DA can also take appropriate legal action against you.

- You must at your own expense, obtain all equipment and services that are necessary to take part in this competition.
