# Winning at life with 1Life Smile FM Radio Competition – October/November 2024

The promotor of the competition is 1Life Insurance Limited (herein after referred to as "1Life"), a licensed Life Insurer and Financial Services Provider, whose registered office is at Auto & General Park, 1 Telesure Lane, Riverglen, Dainfern, 2191.

All 1Life competitions are conducted in accordance with the provisions of Section 54 (1) of the Lotteries Amendment Act (46 of 2001).

# **DURATION OF THE COMPETITION**

1 The competition commences on 24<sup>th</sup> of October 2024 and ends on the 1<sup>st</sup> of November 2024. After this date and time no further entries to the competition will be permitted.

### WHO MAY ENTER THE COMPETITION

2 This competition is only open to South African citizens over the age of 18.

# WHO MAY NOT ENTER THE COMPETITION

- 3 The competition is not open to-
  - 3.1 Directors, members, partners, agents, employees or consultants of 1Life Insurance and/ or any of their associated or affiliated companies and/ or agencies or any supplier of goods or services in connection with a competition; and
  - 3.2 the spouse, life partner, business partner or associate, or the natural or adopted parent, child or sibling, of any person specified in the above.
- 4 You may not participate in or be eligible to win a competition if you have won a competition promoted by 1Life Insurance within the past three months. # HOW TO ENTER

  - 5.2 People who have entered the competition on the website, will also have an option to opt in for an obligation-free 1Life Life Cover quote.
  - 5.3 The radio station chooses a lucky person and calls them to participate on-air.
  - 5.4 The listener needs to pick one of the 5 boxes labelled [1] [L] [I] [F] [E] to WIN.
  - 5.5 Each box contains a different cash prize (starting from R2000, one of these 5 boxes has a grand prize of R8 000 cash. If the listener has opted in for an obligation-free Life cover quote from 1Life Insurance they get a BONUS cash prize of R2 000.
  - 5.6 The winner then wins what's behind their chosen box.

5.7 THEN (BONUS) each winner will have a chance to win a bonus cash prize of R2000 if they have received an obligation-free 1Life Life cover quote.

# HOW MANY TIMES CAN YOU ENTER?

6 Only one entry will be accepted per person, per week. Multiple entries from the same person will be disqualified.

# PRIZES

- 7 WIN your share of R50 000 in cash and stand a chance to win up to R10 000 daily.
- 8 Prizes will be paid out within 30 business days after the receipt of all valid required documents and completion of ITC checks.

# **REQUIREMENTS YOU MUST MEET TO USE THE PRIZE**
